### **Description of Position:**

Under general supervision, performs protective service work in the field, enforcing laws and ordinances relating to animal control. Work includes interacting with the general public, enforcing laws and apprehending and impounding animals. Responds to complaints concerning animals at large, cruelty to animals, injured animals, animals creating a nuisance and animal attacks on humans and other animals. Responds to livestock, wild stock, exotic animals and domestic calls for service. Work is performed under the supervision of the Law Enforcement Lieutenant.

#### **Duties and Responsibilities:**

\*Assisting in the intake of animals into the shelter. \*Assisting with the care & cleaning of animals and kennel areas. \*Processes paperwork for animals that are brought in as stray or adoptions. \*Performs & assists with the necessary euthanasia of animals. \*Excellent customer service skills are required, including strong communication & interpersonal skills & the ability to deal tactfully with the public and explain laws & ordinances. \*Investigates alleged animal bites to humans or domestic animals, including checking for current rabies vaccinations & County registration, quarantining animals, ascertaining rabies symptoms or potential symptoms & releasing animals from quarantine. \*Issues warnings & citations to owners of animals in violation of County ordinances & testifies to those citations in County Court. Additionally, maybe required to testify in criminal proceedings. \*Maintains agency vehicle, ensuring cleanliness & adequate supplies. \*Assist with coordinating outside functions. \*Dependable and punctual attendance is an essential function of this job. \*Perform additional duties incidental to or inherent of the position that may be required through necessity of given situations.
